(C) Technical Specifications of the whole work:

(i). **FIRE ALARM PANEL**: 24 Zone, complies with UL-864 and NFPA-72, 20 X 4 Dot matrix LCD display, touch keypad for user friendly operation, 1000 Event storage with RTC, Peer to peer network facility through RS485,TCP/IP module and PC software (optional) MODBUS for BMS integration (optional); Maximum 16 panels can be connected in a single network. External zone wise sounder/contact via RS 485(optional). Facility to connect public address system(PA) through RS 858 communication.

The panel should be of free standing floor/wall mounting consols as required and out of CRCA sheet steel. Suitable terminal blocks shall be provided for termination of external cable/wires. The panel shall essentially consist of (a) Fire Alarm System, (b) Fault Alarm System (open circuit & short circuit) and complete with all equipments necessary for the reception, control monitoring for the activation of fire alarm sounders. Panel shall be suitable to accept electric feeding of 230 (\pm 10%) volts, single phase, 50 (\pm 5%) HZ, A.C. Supply for system operation and also shall have the power pack unit i.c. battery and battery charger.

The panel shall consist of all solid state electronic circuit of plug in printed circuit cards duly coated with the protective layer to prevent corrosion due to atmospheric contaminations/moisture and shall also have audio/visual alarm for power supply failure, battery voltage low, etc, as per general practice. The panel shall have test facility to check alarm circuit/indicator. The panel shall also have necessary Voltmeter /Ammeter for both A.C./D.C. supply and reset button. The facility shall be provided on the panel for deliberate isolation of each zone and the circuit shall be such that the operation/isolation of one zone and acknowledgement of alarm for one zone, the operation of other zone(s) shall not be prevented.

- (ii). ALARM SOUNDER/SPEAKER (MCP HOOTER): The Alarm Sounder shall consist of necessary solid state electronic circuit or printed circuit card, suitable to accept impulse from fire alarm panel. If required, necessary line matching transformer shall also be included with the sounder. The speaker of the sounder shall preferably be housed in a fibre glass box and rating shall be 4 watt, 8 Ohm.
- (iii). **P. A. SYSTEM**: Suitable Public Address System comprising Microphone & Amplifier unit shall be coupled with the Fire Alarm System in such way that the P.A. System will come into operation in case of Fire Alarm, having the manual override facilities.
