- 9. The bidder should possess minimum 3-years experience in supply, installation and maintenance of cameras and other related major equipments. The authorized bidder must have a minimum annual turnover of Rs. 25 Lac, failing which the bid will be rejected. The bidder shall append a certificate with the bid that the firm has not been debarred/blacklisted for any reason/period by any Central/State Govt. Dept/University/PSU etc. If so, particulars of the same may be furnished. Concealment of facts shall lead to cancellation of the order.
- 10. Installation of the entire CCTV Intelligent Surveillance System shall be the responsibility of the firm. Damage to goods or any other loss due to accident etc. during transit shall be the responsibility of the supplier/bidder. Bidder should use existing network infrastructure of Computer (if desired so) of the Bank for effective resource utilization. Prospective bidders/agencies must visit the location/site for getting detailed Camera positions and DVR location at the Control Room and for proper understanding of other scope of works before submitting the quotation.
- 11. The Bank authority reserves the right to accept or reject any or all the bids or negotiate on any of the tender specification/items/conditions and to annul the bidding process and reject all the bids at any time prior to placement of order without assigning any reason thereto and without any obligation to inform the affected bidders.
- 12. The bidder must append the following documents with the bid:
- a. Copies of PAN/TAN
- b. Copies of Sales Tax Number along with latest Sale Tax clearance certificate
- c. Copies of Service tax & VAT Number
- 13. The Payment terms shall be as under:-
- a. The supplier shall raise the invoice/bill after the supply of material and satisfactory installation.
- **b.** Payment will be released within 45 days after satisfactory installation/assembly report submitted by the Inspection Committee/Committee of Experts.
- c. Service Tax and any other Statutory Tax/Cess/Levy shall be deducted at source as per Rules prevalent at the time of payment and will be deposited with the quarter concerned.
- d. Bank charges, if any, shall be borne by the supplier.
- 14. The bidder will provide 03 years' On-Site Warranty on all equipments and will also specify the post warranty comprehensive annual maintenance rates and their established service centers near Kolkata for providing after sales service support for another 2 years failing which bid would be liable to be rejected.
- 15. The period of supply and installation of the equipment will be specified in Work-Order in terms of number of days. If delay is caused in any circumstances beyond the control of the successful bidder, the successful bidder may request the bank for extension of date /time which may or may not be granted. The Bank authority may impose a penalty @1% per day subject to a maximum of 10% in all of the cost of the bid for the delay.
