Notice Inviting Quotation (NIQ)
Sale of Scrap

Sealed Quotations are invited by The ICMARD, the training institute of The WBSCARDB Ltd. from the bonafied Scrap Vendors having GST Registration Certificate 'as is where is basis' for disposal of obsolete /scrap materials of the ICMARD Building. The intending parties /scrap Vendors should inspect the above site/ location containing the scrap disposable items (as listed and attached herewith) before submitting their quotations with Rate and Quotation should be submitted for each item separately in the format as specified in Anexure-1. The terms & conditions, as specified/appended below should be strictly followed at the time of submission of their quoted rates. :-

1. The intending purchasers may physically inspect the site / location for observation of the scrap materials on any **working day from 11AM to 4PM. up to August 20 ,2022.**

2. The intending purchasers / Scrap vendors would quote / offer item-wise rates / prices for each item as specified in the enclosed format (Anexure-1). The quantities of disposable /scrap item as indicated in the list of scrap materials (Anexure-1) may vary i.e. increase or decrease which would be ascertained / assessed as per actual quantity of scrap materials to be collected pertinent to the said list and as such ,the offered rates /prices would be determined proportionately based on the actual quantities of such materials to be received on spot.

Lump Sum rate over the individual item or overall broad head items of the scrap materials would also be allowed.

3. **Successful highest Bidder will have to deposit the offer value at least 03(three) days prior to taking the delivery of the materials.**

4. Arrangements of labours for any services ,if necessary for identification, segregation or removing of materials have to be made by the selected bidder. The bank will not be involved in the process of procurement of labours,Cranes or other machineries required by the selected bidder and will not bear any cost towards removal of the scrap materials. If the successful bidder fails to lift the materials within 15 days from the date of issue **of the Sale order from** this end, storage charges @ Rs.1% of the tender value for three days or part there off will be charged up to 15 days after which the order will be treated cancelled.

5. The intending bidders, with due permission, should visit and jointly inspect the site along with the bank Officials for the scrap materials before quoting the offer value.

6. GST will be recovered as per applicable rate separately by the bank from the successful Bidder along with Offer value. This amount will be over and above the offer value.

7. **The successful highest Bidder will have to deposit the offer value plus GST either by Demand Draft or Pay Order drawn in favour of " The WBSCARDB Ltd."**

8. On receipt of the entire amount within stipulated time , a Order for Lifting of scrap materials will be issued by the bank Authority to the successful Bidder observing necessary official formalities.

9. The bid will be awarded to the highest bidder based on the highest offered price. However, if the price offered by the highest responsive bidder is found not to be acceptable, negotiation may be held with the bidder. In case , Such negotiation dose not provide the desire result ,the next reasonable or acceptable price will be counter – offered to the next highest responsive Bidder.

10. The Bank Authority reserves the right to reject any or all the quotations without assigning any reason thereof.

11. The sealed cover of quotation should be superscribed as “ Quotation for sale of scrap material “

12. The rates of the scrap materials in terms of Annexure-1 should be furnished in the company’s letter head with official seal ,complete in all respects and the sealed quotations must reach before the Principal , ICMARD Building,(3RD.floor) ,14/2, C.I.T.Scheme- VIII (M), Ultadanga, Kolkata-700 067, by August 31, 2022 up to 4.00 PM. The received quotations if found incomplete or technically defective ,shall liable to be rejected.
