A. Qualifications of the Bidder:-.

- a) The Bidder should be an Agency registered in India.
- b) The Bidder should have at least one Office and Service Centre in Kolkata to administer, supervise and maintain the system to be installed.
- c) The Bidder should have experience in successful implementation of at least two similar natures of works in Public Sector Units or in organizations.

B. System Requirement:-

1. LG Digital Interactive Smart Board with Create Board Software (Model No.: 75TR3DK-BG)

- a) The screen has to be 75 inch (Diagonally) in size.
- b) The resolution of the screen has to be 3840 X 2160 (4K UHD) with 16:9 Ratio and equipped with IPS panel technology with viewing angle of 178° X 178° (H X V).
- c) The product should have "CB/NRTL" Safety Certification.
- d) The product should have OPS (Slot Type) Compatibility and Built-In OPS Power supply.
- e) The product should have LG Create Board Software Support, LG Connected Care Support and LG Connected Care DMS Support.
- f) The product should have HDMI (3, HDPP 2.2), RGB (VGA), Audio In, RS-232C In, RJ45 (LAN), USB 3.0 Type A (4), USB 2.0 Type A, USB Type C (USB-PD, DP-Alt) as Input connectivity and HDMI Out, Audio Out (1, Optical 1(SPDIF)), Touch USB (2), RJ45 (LAN) as Output connectivity.
- g) The product should have Touch Input with a Maximum of 40 multi-touch points.
- h) The product should have 2 Nos. of Speaker (15W each).
- i) Operating system Android 11. Windows 7 / 8 / 10 / Linux / Mac / should be supported by the product.
- j) The product should have Quad Core A55 CPU, Mali G52MP2 GPU, 32 GB Internal Memory, 4 GB RAM, Wi-Fi 802.11 a/b/g/n/ac/ax (Wi-Fi 6)& Bluetooth 5.0 Support.

2. LG 4K UHD Commercial TV (43UR801C)

- a) The screen has to be 43 inch (Diagonally) in size.
- b) The resolution of the screen has to be 3840 X 2160 (4K UHD) with HDR10 / HLG support.
- c) The product should have HDMI Input (3, Supports eARC, HDMI 2.1), Simplink (HDMI-CEC), HDMI Audio Return Channel (eARC (HDMI 2)), USB Input (2, V 2.0), Wi-Fi 5, Bluetooth 5.0, Ethernet Input, RF Input (2, Antenna / Cable), SPDIF (Optical Digital Audio Out).
- d) The product should have 2 Nos. of 2.0 Channel Down Firing Speaker (10W each).

e) The product should have Quad core a5 AL 4K Gen6Processor equipped with 4K Upscaling.

3. HDMI Splitter

- a) The HDMI Splitter should be compatible upto 4K resolution.
- b) The HDMI Splitter should have 1 Input Port and 2 Output Port.

4. Steel TV Cart

- a) The cart should be suitable for 75" Smart Board.
- b) The cart should have movable and lockable wheels.
- c) The cart should be height adjustable.

C. Responsibilities of the contractor/vendor:-

- a) Supplying and installation of all the Hardware as described in ANNEXURE I.
- b) The vendor should arrange a demonstration and a professional training on the whole system to the selected employees of the Institute.
- c) After demonstration and training, the vendor should handover the system to the authority of the Institute as well as Hardware Manuals. After handing over, the Vendor should provide Warranty of the system for a period of **36 months for Sl. No. 1 of Annexure I & 12 months for Sl. No. 2 of Annexure I** starting from the date of successful installation of the system.

D. Payment Terms:-

- a) On successful supply & installation of the items as described in Annexure I, separate Onsite Installation Reports have to be submitted duly certified by AGM & FM, ICMARD. The bill is to be submitted to ICMARD situated at ICMARD Building, 3rd Floor, Block 14/2, C.I.T. Scheme VIII (M), Ultadanga, Kolkata 700067.
- b) Payment will be released on successful supply & onsite installation of the items as described in Annexure I and on receipt of Onsite Installation Report and on production of bill in duplicate.
- c) Statutory deductions at applicable rates will be made from the billed amount as per prevailing rules.

E. Bid package:-

- a) All documents mentioned in Clause F. General Terms & Conditions must be uploaded in the GoWB Portal: whenders gov. in in the Technical Bid Cover and have to be signed digitally.
- b) The name of the Bidder, registered address and the rates against the items must be filled in the specified boxes in the BOQ format and have to be signed digitally.

F. General Terms & Conditions

- a) The Quotation must be valid for a period of at least 3 [Three] months from the last date of submission.
- b) The rate uploaded in the BOQ format must be inclusive of all taxes, delivery, and installation and demonstration charges.
- c) Quantity of items/ equipments may be increased or decreased depending upon the decision of the Institute Authority.
- d) During evaluation of the Quotation, the Institute may, at its discretion, ask the Bidder for clarification of Bids. The request for clarification and the response may be in writing or verbal, as the case may be. If during execution of the work, any new item/accessory is required for proper functioning of the system, such items shall be considered incidental to the work and no payment will be made to the executing agency for such item.
- Total cost of the Bid will be the deciding factor while deciding the Bid in favour or against any Bidder. Incomplete Bid will be liable to be rejected.
- f) The right to reject the lowest or all the Quotations without assigning any reason thereof is kept reserved by the competent authority of the Institute.
- g) The Bidder shall append a **Certificate** with the Bid that the Bidder has not been debarred/ blacklisted for any reason/period by any Central/State Govt. Dept/University/PSU etc. If so, particulars of the same may be furnished. Concealment of facts shall lead to cancellation of the order.
- h) Installation of the entire System shall be the responsibility of the Bidder. Damage to equipments or any other loss due to accident etc. during transit shall be the responsibility of the Supplier/Bidder. Bidder should use existing network infrastructure of Computer (if desired so) of the Institute for effective resource utilization. Prospective Bidders/Agencies must visit the location/site for getting detailed positions and location and for proper understanding of other scope of works before submitting the Quotation.
- The authority of the Institute reserves the right to accept or reject any or all the Bids or negotiate on any of the tender specification/items/conditions and to annul the Bidding process and reject all the Bids at any time prior to placement of Order without assigning any reason thereto and without any obligation to inform the affected Bidders.

b. Copies of GST Registration Number along with GST Registration Certificate.

c. Balance Sheet for last three consecutive Financial Years.

k) The Bidder will provide **03 (three) year Warranty** on Sl. No. 1 of ANNEXURE – I and **01 (one) year Warranty** on Sl. No. 2 of ANNEXURE - I failing which Bid would be liable to be rejected.

1) The period of supply and installation of the equipment will be specified in **Work-Order** in terms of number of days. If delay is caused in any circumstances beyond the control of the successful Bidder, the successful Bidder may request the Institute for extension of date /time which may or may not be granted. The Bank authority may impose a **penalty @1% per day** subject to a maximum of 5% in all of the cost of the Bid for the delay.

m) Rates & Specification of make/brand for all the items must be quoted/ mentioned in proper column of Annexure-I which shall be duly signed & stamped. Evaluation will be done on the basis of Grand Total Price.

n) The equipments, which are not found in order according to specification and are thus not accepted, should be lifted back by the successful Bidder at his own cost/risk.

o) The legal dispute, if arises, shall be subject to the jurisdiction of the Courts at Kolkata and Courts in other jurisdiction shall have no legal sanctity.


