## Guidelines for Online Application Registration Process

**Please Read the “Expression of Interest” carefully before proceeding for Registration**

The following steps are required to fill up the online application form:

1. Every Applicant (Individual and Training Agency) must have valid Email Id for login and verification.
2. Please make sure the Non-Refundable Application Fee has been paid by NEFT/ RTGS/ IMPS to the Bank Account stated in the “**Expression of Interest**”.
3. Keep the UTR No./ Transaction No. and Date of Transaction handy.
4. **Ensure all the required documents are scanned in PDF/ JPG format as stated below.**
5. **For Organisations-** Ensure that the Soft Copy in MS Excel of the following 2 formats are duly filled up and ready to be uploaded

**a. TRAINER DETAILS**

**b. AVAILABLE INFRASTRUCTURE DETAILS**

6. Visit the Registration Page on [www.icmard.org](http://www.icmard.org).
7. Enter the required information in the Registration Page.
8. Read the EoI and click on the “ACCEPTED” button to proceed.
9. Fill the online form along with uploading of the documents.
10. Click on the Checkbox beside “Declaration” and then Submit the form by clicking on the SUBMIT button.
11. An E-mail containing application number and login ID information will be forwarded to your registered email ID.
12. Note: Please note down the application number carefully as you need to essentially mention it in all your future correspondence queries related to your application form.
